Ladies and Gentlemen of the NCGOP,

I am Larry G. Pittman, former member of the NC House, Oct. 10, 2011 through Dec. 31, 2022. To my knowledge, I am the only one ever to have served in our State Legislature who ever went to jail for saving babies from abortion at abortions mills. I was a member of the Pastoral Advisory Committee of Action League for Life in the Charlotte area. Not only have I been arrested for saving babies, I also took part in raiding the dumpster at the Hallmark Clinic in Colwick Towers in Charlotte in the summer of 1992. The night that I went, we retrieved the remains of 32 aborted babies from that dumpster. Over the five nights of this activity, we found the remains of 128 babies illegally thrown into the dumpster, most of them the consistency of hamburger. There were also some identifiable body parts, crushed heads, arms with scapula attached, rib cages, stomachs and other parts. One leg from the knee to the toes was identified by a neonatal intensive care nurse from Fayetteville as being twenty weeks gestation. Any decent person who held that in their hands as I did should know that no matter what the reason was, there is no excuse for it. Thankfully, Belmont Abbey College gave them decent burial on their campus.

While I was in the NC House, I got sick and tired of supporting bills that really did little or nothing to save babies. I ran HB 158 Constitutional Amendment / Life at Fertilization in 2021 to abolish abortion, infanticide and euthanasia in North Carolina from fertilization until natural death. It would have allowed the people of this State to vote on whether to put an end to legal abortion in our State by amending our Constitution. However, because getting reelected was more important to our "leadership" than justice, the bill was not allowed a hearing. Since then, a worthless bill has been passed which allows abortion up until twelve weeks. That is useless, as over 90% of abortions in North Carolina occur before twelve weeks.

Whenever my wife and I visit our daughter in South Carolina, as we come back on I-85, we are confronted with a sign that says, "Abortion is still legal in North Carolina." As a native of North Carolina, as a Minister of the Gospel, that sickens me, as it should all of us. As a former member of the North Carolina House of Representatives, it is an embarrassment, although I am not the one who failed at least to try to change it. As a member of the North Carolina Republican Party, it infuriates me, because that does not uphold what our Party Platform calls for us to do.

The scheduling of conventions this year was too rushed and truncated to allow all Congressional districts the time to submit resolutions to the State Convention. Whether intentional or not, this disenfranchised citizens in those districts in which our conventions were not able to be held before the deadline set by the State Party Resolutions Committee. I was able to present an abortion abolition resolution at the 8th District Convention, which was passed with only about four no votes out of over 100 delegates, but it was too late for the State Party Resolutions Committee deadline. Therefore, I implore the delegates here to allow my resolution to be heard by this State Convention. The Bible clearly tells us that the shedding of innocent blood defiles the land. How many more millions of innocent children must die before we obey the God to Whom we pray? Let us please pass this resolution and call on our Legislature finally to do what is right in God's sight by passing a law to put this disgusting destruction of human life to an end in our State. Perhaps He may yet restore our greatness.

Resolution to Abolish Abortion

Whereas, Article 4.1 of the North Carolina Republican Party Platform states: *“We believe in the sanctity of **all** human life. Unborn children have constitutional rights to life and liberty and, the government must respect and protect **all** innocent human life from conception to natural death.”*[Emphasis added.]¹

Whereas, the value of human life is not based upon the circumstances of conception including children conceived in rape and incest, as ALL children have inherent worth as a reflection of their Creator and are included in the North Carolina Republican Party Platform’s category of **“all”** human life under Article 4.1.

Whereas, on June 24, 2022, the United States Supreme Court issued its decision in Dobbs v. Jackson Women’s Health Organization, 597 U.S 215. Quoting from its decision: *“Abortion presents a profound moral question. **The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion.**”*[Emphasis added.]²

Whereas, North Dakota, South Dakota, Idaho, Texas, Oklahoma, Missouri, Arkansas, Louisiana, Mississippi, Alabama, Tennessee, Kentucky, Indiana, and West Virginia have completely banned and/or made abortions unavailable.³

Whereas, **ALL** unborn children in the State of North Carolina are vulnerable to abortion under the current “12 week ban,” as each child must pass through the first 12 weeks of human gestation to be protected from abortion.

Whereas, a medical separation procedure performed during a medical emergency **in order to save the life of the mother** is NOT an abortion (the intentional killing of the unborn child during the process of separation).

Whereas, dignified, humane treatment of an unborn child who does not survive a medical separation procedure is NOT an abortion.

Whereas, the North Carolina General Assembly has legal authority to abolish abortion within the borders of North Carolina.

Whereas, Article 4.11 of the North Carolina Republican Party Platform states: *“We oppose the sale, purchase, possession, or use of fetal tissue or body parts obtained from induced abortions.”*⁴

Whereas, the use of tissue from aborted children in the development of vaccines and in medical research negates the value of all human life.⁵

Whereas, in April 2021, the National Institutes of Health reversed Trump era restrictions on research using tissue from aborted children,⁶ such that aborted children have once again been made available for sale.⁷

Whereas, ALL North Carolina school children are required by law to receive multiple vaccines developed using cell lines of aborted children,^{8,9,10} and therefore, the children of Pro-Life North Carolinians are required to participate in abortion, or assert a medical or religious exemption on their children's behalf.

Whereas, beginning in 2021, all North Carolinians were required to receive Covid-19 vaccines, all of which were developed using cell lines of aborted children (Pfizer and Moderna: HEK293) and (J&J: PER-C6),¹¹ thereby forcing Pro-Life North Carolinians to participate in abortion, assert a medical or religious exemption (often denied), and/or face discrimination, employment termination, or other life-changing consequences.

BE IT RESOLVED, that the North Carolina Republican Party calls upon the North Carolina General Assembly to enact legislation, consistent with the Party Platform, to abolish abortion and subject providers who perform abortion to criminal penalties.

BE IT FURTHER RESOLVED, that the North Carolina Republican Party calls upon the North Carolina General Assembly to enact legislation to end the use of cells, cell lines, tissues, organs, and any other body part of aborted children in research and scientific experimentation, and subject violators to criminal penalties.

BE IT FURTHER RESOLVED, that the North Carolina Republican Party calls upon the North Carolina General Assembly to enact legislation to end the use of cells, cell lines, tissues, organs, and any other body part of aborted children in the development of vaccines, pharmaceuticals, medicines, cosmetics, and any other product for use, sale, manufacture, testing, or distribution in the State of North Carolina, and subject violators to criminal penalties.

Most Common Fetal Cell Lines and Their Uses (Chronologically Ordered)

CELL LINE	YEAR	AGE	GENDER	CELL TYPE	HISTORY AND USES
WI-38	1962	12 weeks	male	fetal lung	Specimen No. 38, 32nd abortion, in Sweden. Shipped to Leonard Hayflick, Wistar Institute, Philadelphia. Used to culture RA273 for rubella and MMR vaccines and study lifetime of <i>in vitro</i> cell lines. ^{1,2}
WI-44	~1963	12 weeks	female	fetal lung	Specimen No. 44, 38th abortion, in Sweden. Shipped to Leonard Hayflick, Wistar Institute, Philadelphia. Used along with WI-26 and 38 to study lifetime of <i>in vitro</i> cell lines. ³
RA273	1964	6 weeks	unknown	fetal kidney	R=rubella, A=abortion, 27=27th baby, 3=3rd tissue. Rubella virus obtained from aborted fetus kidney used in Rubella and MMR vaccines. At least 99 abortions to create the rubella vaccine alone. ⁴
MRC-5	1966	14 weeks	male	fetal lung	Medical Research Council, abortion #5. Baby aborted for psychiatric reason, 27-year-old physically healthy woman. Used in (some) Polio, Rabies, Chickenpox, Hepatitis-A, Zostavax for shingles vaccines. ⁵
HEK-293	~1972	unknown	female?	fetal kidney	Human Embryonic Kidney, specimen #293, abortion in the Netherlands. Used for basic research. Used widely in pharmaceutical research, development, and production, especially in vaccines. ⁶
IMR-90	1975	16 weeks	female	fetal lung	Designer cell line to replace WI-38. Gestational age determined by fetal weight, shoulder to rump length of 7 cm. "... no apparent physical abnormalities." Abortion in US; Coriell Cell Repository. ^{7,8}
Lambda.hE1	~1980	second trimester	unknown	fetal liver	Abortion in US. Liver tissue from a second-trimester Caucasian fetus aborted for psychosocial indications, no obvious abnormalities. Used in Procrit, Epoetin α , Epogen, Aranesp, Darbepoetin alfa. ⁹
IMR-91	~1982	12 weeks	male	fetal lung	Designer cell line to replace MRC-5. Obtained after a abortion by hysterectomy at the time of sterilization on a 41-yr-old white female who was also a "one pack-a-day cigarette smoker." ^{10,11}
PER-C6	1985 1995	16-18 weeks	unknown	fetal retinal	Designed for the pharmaceutical industry, especially vaccines. Cells were frozen in 1985, thawed in 1995. Abortion in the Netherlands, "mother wanted to get rid of the fetus, father unknown." ¹²
WALVAX-2	2015	12 weeks	female	fetal lung	Designed to replace depleting supply of WI-38 and MRC-5. Abortion in China, 9th abortion, due to presence of a uterine scar from a previous cesarean birth by a 27-year-old healthy woman. ¹³
